(CHAIRMAN'S REPORT: Dr. Howard Seeman has been an important member of our department. He epitomizes the consummate professional by virtue of his high level of educational research, excellent classroom teaching, and his significant articles, publications, and scholarly papers that have been received with high praise from leaders in the field.
